Appendix One: Questionnaire

#### 1. Background

1.1 Around 25% of care home residents in the United Kingdom have diabetes. Guidelines exist for good clinical practice for care home residents (Diabetes UK 2010), yet national audit data (IDOP 2013) suggests significant variations in care with access and training for care home staff variable indicating the workforce caring for vulnerable people have insufficient knowledge and skills to do so.

#### 2. Aim

- 2.1 The aim of the survey was:
  - To identify the current levels of diabetes care provision with residential care homes
  - To Identify any specific training and education deficits to support diabetes care in care homes
  - To assist Telford & Wrekin CCG commissioners to address diabetes specific quality standards and resources required for residential care home residents & staff

#### 3. Objectives

- 3.1 The objectives of the survey were:
  - To identify if care homes have diabetes specific policies in place for diabetes, hypoglycaemia management & screening for diabetes
  - To identify if residents with diabetes have a diabetes care plan in place with annual review
  - To identify if care homes have diabetes procedures in place to ensure residents with diabetes have an annual review with their GP, & have received their annual foot & eye screening assessment if eligible
  - To identify whether care home staff have accessed any diabetes training in the last 12 months
  - To identify whether care home staff have accessed diabetes any training more than 12 months ago
  - To identify whether staff undertaking capillary blood glucose monitoring have completed a competency assessment
  - To identify whether staff undertaking insulin administration have completed a competency assessment
  - To assess diabetes knowledge levels before completing a diabetes structured education programme of non-registered practitioners
  - To assess diabetes knowledge levels 3 months following completion of a diabetes structured education programme for non- registered practitioners

#### 5. Sample

5.1 Six care homes will be targeted from the Telford & Wrekin CCG locality identified as frequent users of ambulance & hospital services for diabetes related problems.

#### 6. Data Sources and Methodology

- 6.1 Data source for this survey was a paper questionnaire completed by the Care Homes.
- 6.2 Information from the completed questionnaires was recorded and analysed using Microsoft Access.

#### 7. Results

- 7.1 Eight Care homes completed the audit between 10<sup>th</sup> January and 27<sup>th</sup> January 2014, four of these care homes were residential (standard), one Nursing (EMI) and three Residential (EMI). Two residential (standard) care homes stated they were additionally Residential (EMI) and one residential (standard) Dual Registered (EMI).
- 7.1.1 Table one represents the number of non- registered practitioners and nursing staff working at the Care Homes.

7.1.3 Table two demonstrates that Lightmoor omitted the age of four patients and Farcroft did not record any ages of their residents. Table two demonstrates that over 88% of residents were in the age range 74 to over 90 years of age and of these over 22% were over 90 years of age.

#### 7.2 Residents Information

7.2.1 The first question referred to the number of residents having Diabetes. A total of 35 residents have diabetes across five of the eight care homes ranging from four to nine residents.

7.2.2 Questions six to eight: Question six asked "How many of your residents who have diabetes require insulin?" Four homes had eight residents between them who required insulin. For the residents on insulin three external care professionals and one qualified nursing member of staff were responsible for administering the insulin. 100% of staff at all the care homes were aware of residents who are at increased risk of hyperglycaemia.

#### 7.3 Policies

It was noted that Lake View did not respond to any of the questions in this section and six of the care homes did not answer if they had a designated member of staff with the responsibility for diabetes management.

7.3.1 Table four demonstrates that over 71% of care homes were aware of the "Good Clinical Practice Guidelines for Care Home residents with Diabetes". 100% of residents with diabetes have a documented care plan, 57% of care homes have a written policy for managing hyperglycaemia, whilst only one care home, 14%, had a policy for screening diabetes and only one care home a nominated member of staff who has designated responsibility for diabetes management.

#### 7.4 Procedures (N=8)

One care home did not respond to questions one to seven.

- 7.4.1 Question one: Do you ensure each resident with diabetes has an annual review arranged with their GP?
  - 100% of care homes who responded ensured their residents had an annual review with their GP.
- 7.4.2 Question two: How often do your residents with diabetes at risk of diabetic foot disease have a foot review by a podiatrist?
  - 37.5% (3) of residents at risk of diabetic foot disease have an annual foot review by a podiatrist.
  - 25% (2) had a monthly review by a podiatrist
  - 37.5% (3) of staff completing the questionnaire either did not know the reply or omitted a response.
- 7.4.3 Question three: How many of your current residents with diabetes have a foot ulcer?
  - Only one resident in one care home, with diabetes, had a foot ulcer.
- 7.4.4 Question four: What number of your residents with diabetes received an accredited diabetic retinopathy retinal screening in the last 15 months?
  - Six patients were recorded as having screening in the last 15 months. Three care homes stated they "Don't know" if their diabetic patients had screening due to:
    - All have eye tests by outside clinic including retinal screening. As had new residents in last 15 months
    - Some families take to appointments & not always informed.
    - The other care home did not give a reason for not knowing.
- 7.4.5 Question five: How many of your residents with diabetes receive an annual flu vaccination?
  - 100% of residents at care homes receive an annual flu vaccination unless refused by the resident.
- 7.4.6 Question six: Are there any dietary restrictions or amendments made for residents who have diabetes?
  - Five (62.5%) of care homes made amendments or dietary restriction for residents with diabetes.
  - Two (25%) of care homes made no amendment or dietary restriction.
  - One (12.5%) care home did not reply to the question.

- 7.4.7 Question seven: How many of your residents with diabetes who have their insulin given by a non-registered practitioner have signed a consent form for delegation to take place?
  - None of the care homes had insulin given to a resident by a non-registered practitioner.
- 7.4.8 Question eight: Are residents care plans reviewed quarterly by a registered health care professional/practitioner where delegation of insulin administration has taken place?
  - One care homes diabetic residents had their care plan reviewed quarterly.
  - One care homes diabetic residents had their care plan reviewed monthly.
  - Three care homes diabetic residents did not have their care plan reviewed quarterly.
  - The remaining care homes did not know or omitted to answer.
- 7.4.9 Question nine: Is insulin for each resident stored in a container clearly marked with the patients name and name of insulin, in line with the CQC Professional advice the administration of medicines in care homes?
  - Four care homes stored insulin correctly.
  - One care home did not.
  - The question was not applicable to the other care homes.

#### 7.5 Staff Knowledge

- 100% of staff have access in care homes have access to local training and education courses in diabetes offered by the CCH, NHS providers. This training is free to all staff
- Three care homes had a total of 23 staff who have received formal training and education in diabetes during the last 12 months
- Two care homes had a total of 33 staff who have received formal training and education in diabetes more than 12 months ago
- Two care homes had no care staff who had received any training recognising and dealing with hypoglycaemia
- Six care homes had a total of 100 care staff who have received training in recognising and dealing with hypoglycaemia
- Four care homes had no care staff who had received training in the dietary needs of residents with diabetes
- Four care homes had a total of 89 staff who have received training in the dietary needs of residents with diabetes
- 100% of staff knew who to contact if a resident with diabetes required further care. They would contact the residents
  - G.P
  - District nurse initially and diabetic nurse specialist
  - District nurses. Ask for referral to dietician/diabetes nurse
  - GP or diabetic specialist nurse
  - Diabetes nurse
  - GP, Diabetic nurse at hospital or District Nurses
  - Lizzy & Rebecca, Shrewsbury
- 45 HCA's across six care homes are responsible for Capillary Blood Glucose Monitoring
- None of the HCA's were responsible for observing the administration of insulin by residents

- None of the HCA's were responsible for the administration of insulin
- Thirty two HCA's across five care homes had capillary blood glucose monitoring competencies formally assessed. Twenty five of the 32 had competency documentation completed
- Five care home staff in one residential home had subcutaneous insulin administration competencies formally assessed with supporting competency documentation completed
- Two care homes operate a recall system so that HCA's competencies are re-assessed annually. One care home does not operate a recall system and the other care homes did not respond to this question

#### 8. Conclusions

- 8.1 Eight Care Homes completed the audit during the month of January 2014. The age of residents ranged from less than 65 years to over 90 years. Over 88% of the residents were in the age range 74 to over 90 years of age whilst 22% were over the age of 90 years. Five of the eight care homes had a total of 35 residents with diabetes. Four of the eight care homes had residents who required insulin.
- 8.2 Over 71% of care homes were aware of the "Good Clinical Practice Guidelines for Care Home residents with Diabetes" and 100% of residents with diabetes have a documented care plan.
- 8.3 100% of care homes ensured their residents had an annual diabetes review with their G.P. Over 37% of the care homes ensured that their residents at risk of diabetic foot disease had an annual foot review by a podiatrist, whilst 25% of residents had a monthly review by a podiatrist. 100% of residents at care homes receive an annual flu vaccination unless refused by the resident. Six patients with diabetes were recorded as receiving an accredited diabetic retinopathy retinal screening in the last 15 months; however one care home remarked that some families take the resident to appointments and do not always inform the care home. Five (62.5%) of care homes made amendments or dietary restriction for residents with diabetes however two (25%) of care homes made no amendments or dietary restriction. None of the care homes had insulin given to a resident by a non-registered practitioner. One care home (12.5%) had their care plan reviewed quarterly where delegation of insulin administration had taken place. One care home (12.5%) reviewed the care plan on a monthly basis whilst three care homes (37.5%) did not review their care plans on a quarterly basis. Four care homes (50%) stored insulin correctly, whilst one care home (12.5%) did not. The question was not applicable to the other care homes.
- 8.4 100% of care home staff have access to free local training and education. Care home staff have received:
  - formal training and education in diabetes
  - training in recognising and dealing with hypoglycaemia
  - training in the dietary needs of residents

100% of care home staff knew who to contact if a resident with diabetes required further care. 45 HCA's across 6 care homes are responsible for capillary blood glucose monitoring, none of the HCA's were responsible for observing the administration of insulin by residents. 32 HCA's across five care homes had capillary blood glucose monitoring formally assessed.
